LEIGH PARISH COUNCIL MINUTES

For Meeting Held At Leigh Village Hall On 15th May 2014 At 7.30pm

- 1. APOLOGIES FOR ABSENCE Cllr Holder, Cllr Orchard, Cllr Vincent, DCllr Loder.
- 2. <u>DECLARATIONS OF INTEREST</u> None.
- 3. TO APPROVE AND SIGN THE MINUTES
- 3.1 It was resolved "THAT THE MINUTES OF THE MEETING HELD 20th MAY 2014 BE APPROVED AND SIGNED BY CHAIRMAN". Proposed: Cllr Read, 2nd: Cllr Stilliatano. Agreed unanimously. Cllr Bugler and Cllr Stilliatano signed the minutes. Minutes heading to be altered to read Minutes.
- 3.2 Cllr Scutt expressed her thanks to Cllr Read for his long standing contribution as Chairman to Leigh Parish Council and wished this to be recorded.
- 3.3 Cllr Scutt asked if there had been a response from Cllr Holder regarding 13.1 of May minutes. No response received.
- 3.4 It was noted that electronic sign for speeding had been installed but facing down hill.

- 6. PLANNING MATTERS
- 6.1 Email from Amy Selleck regarding planned development at Grade II listed cottage in Batcombe. The planning application has not yet been received by the Clerk.
- 6.2 APPLICATION NO: WD/D/14/0001053
 PROPOSAL: Single storey extension
 LOCATION: CHURCH FARM, CHETNOLE RD, LEIGH, SHERBORNE, DT9 6HL

- 6.3 Barn outside Leigh at 3 Gates Farm appeared to be being developed. There were concerns from Council that this might set a precedence and enquires should be made to WDDC about Leigh Parish Council responding to this application even though it is outside of their area.
- 6.4 Planning Application WD/D/14/001707 Paul Orchards concerns emailed, but also indicates a conflict of interest and therefore declares an interest. This application has not yet been received by the Clerk, though on the website it indicated having been sent on the 8/7/14. Clerk to chase.

8. BOYLES TRUST

8.1 Letter from Alan Hill indicating he represented Leigh Parish Council for Boyles Trust, having been appointed in 1973. He apologised for missing the May meeting and reporting on the Trusts activities. Grants for children taking up further education amounted to £500 each and for St Andrews School £5000. They do not provide minutes but lodge annual figures with the Charity Commission. He asks if the council wish him to stand down then he would quite understand. The Council responded that they would gratefully appreciate it if he would continue standing. That the Council understood that there were two representatives for Leigh and the presumption was that the other was Mr G Morris. The Parish Council were unsure of their obligations to elect representatives to the Trust and would like the situation clarified. Clerk to request politely a constitution or terms of reference so that the Parish Council could understand more fully their responsibilities, if they in fact have any.
