# LEIGH PARISH COUNCIL MINUTES

# For Meeting Held At Leigh Village Hall On 18<sup>th</sup> November 2014 At 7.30pm

Present: Cllr Holder (Acting Chairman), Cllr Vincent, Cllr Bugler, Cllr Read, Cllr Stillitano, Cllr Bennett, the Clerk, and 3 members of the public.

- 1. <u>APOLOGIES FOR ABSENCE</u> DCllr Loder, Cllr Scutt,
- 2. DECLARATIONS OF INTEREST none declared.
- 3. TO CO-OPT COUNCILLOR
- 3.1 It was resolved that "MR BENNETT BE CO-OPTED ONTO THE PARISH COUNCIL OF LEIGH". Proposed: Cllr Vincent Proposed: Cllr Read, Voted For: Unanimous. Mr Bennett agreed to sign to abide by the Code of Conduct and to complete a Registration of Interest form.
- 4. TO APPROVE AND SIGN THE MINUTES
- 4.1 It was resolved "THAT THE MINUTES OF THE MEETING HELD 16<sup>th</sup> SEPTEMBER 2014 BE APPROVED AND SIGNED BY CHAIRMAN". Unanimously agreed.

#### 5. TRAFFIC SPEED PATROL IN LEIGH

- 5.1 Alan Hill was not able to be present to update regarding formation of Speed Watch.
- 5.2 The Clerk has written a letter to Highways, at County Council regarding the pothole outside the property White Gates on Batcombe road, and this has resulted in repairs.

#### 6. FINANCIAL MATTERS

- 6.1 Different aspects of the budget were discussed, these including play ground relocation and the need to build up a fund to be ring fenced for the future, it was agreed to ring fence £1000.00 for this future project.
- 6.2 It was discussed whether the meeting could be moved to the smaller room to reduce costs. It was agreed to approach the Village Hall Committee to reduce the cost of the meeting in the hall to that rented to local organisations. Clerk to contact the village hall committee.
- 6.3 Alton Mead cost discussed and outcome of visiting the Solicitor appraised. It was agreed that no action would be taken.
- 6.4 It was agreed to add in £200 for contingency cost to the Snow Plan.
- 6.5 It was agreed that provision for the Clerk to use a computer would be made with £180 put into the budget.
- 6.6 It was resolved that "THE LEIGH PARISH COUNCIL WOULD MAKE A DEMAND FOR PRECEPT OF £5500.00 HAVING REVIEWED DRAFT BUDGET." Proposed: Clir Bugler, 2<sup>nd</sup>: Clir Read Unanimously agreed.
- 6.7 Clerks salary for 2 months. Total: £305.94 Unanimously agreed.
- 6.8 Clerks invoice for 2 months broadband at £5 per month, £10. Unanimously agreed.
- 6.9 The rental for Totnell Copse was discussed with a view to the land being common land and therefore not rentable. Common land is land owned collectively or by one person but over which other people have certain traditional rights such as to allow their livestock to graze upon it, to collect firewood or to cut turf for fuel. It was agreed that the Council would no longer charge for the lease.

8.1 It was discussed and agreed that no action was to be taken.

#### 9. <u>ELECTORIAL REVIEW</u>

9.1 Cllr Bugler updated Cllr Bennett on the position of Leigh concerns. Cllr Scutt sent out an outline of the situation so that Councillors could decide how or if they wished to react should the Boundary Commission refuse to uphold their complaint. The floor was unanimous in supporting the parish councils concerns in losing links with the Sherborne area. It was resolved "IF THE RESPONSE THROUGH THE COMPLAINTS PROCESS DOES NOT UPHOLD LEIGH PARISH COUNCILS COMPLAINT THEN LEIGH PARISH COUNCIL SHOULD GO TO THEIR MP AND REQUEST TO MAKE A COMPLAINT TO THE PARLIAMENTARY OMNIBUSMAN THAT THE DUE PROCESS HAS NOT BEEN ADHERED TO IN DEFINING THE NEW BOUNDARIES. IF THE MP IS UNABLE TO SUPPORT THE PARISH COUNCIL THEN AN ALTERNATIVE MP SHOULD BE FOUND TO SPEAK ON THE PARISH COUNCILS BEHALF." Proposed: Cllr Burgler, Seconded: Cllr Holder. Unanimously agreed.

### 10. SNOW PLAN

10.1 It was agreed that Cllr Holder would contact Anthony Mayo regarding snow clearing and get a quotation. It was agreed that Cllr Bugler would update the snow plan and submit updated version in time for this year's cold weather.

## 11. DORSET RIGHTS OF WAY - SERVICE LEVEL AGREEMENT

11.1 Trevor Evans had been asked to look at a proposition from Dorset Rights of Way, that LPC might be interested in entering into a SERVICE LEVEL AGREEMENT(SLA) with Dorset Rights of Way. It was agreed that the Leigh Parish Council would not enter into a Service Level Agreement.

#### 12. WEBSITE

12.1 Jack Paterson has agreed to update the Village Website. He is starting to build the website and he has asked to agree a point of transition, using the same address but using a different hosting company. Karen Bugler will continue managing the web site until the end of March, but there may be a transition in handover before this date.

Reply was "I'm afraid this isn't my area of work I've done a quick web search and haven't been able to find out much it's not an area the council deals with other than the position of them through planning once an operator comes to us. # 14. ITEMS OF URGENT NATURE SUBJECT TO CHAIRMAN'S APPROVAL

- 14.1 Phillipa Toulson spoke on Pogles Wood and the Forest School. It is 4 years to the day since she spoke to the Parish Council on this subject and wished to give an update. The project realised early on that planning consent for change of use was needed and this process has taken 9 months. Agreement was given for continuation of activities until planning permission given. This year 3 initiative activities have taken place 9 children have done their conservation award. They are starting to deliver Adult conservation awards. They have also used the site for a series of adult literature days. Also for schools projects funded by Irnest Cook Trust, for children who underperform in literacy and need to improve their skills. Looking to the future they are in the process of looking to move away from Folke Southwest charity status and become a community initiative. They plan to work with young mothers and become ofsted registered, so they can provide better provision for children of working parents. At present the site is working 2 to 3 days per year between March and November. Due to weather conditions they are planning to put in place a carbon neutral indoor space.
