# LEIGH PARISH COUNCIL MINUTES

# For Meeting Held At Leigh Village Hall On 21st July 2015 At 7.30pm

Present: Cllr Scutt, Cllr Bugler, Cllr Smith, Cllr Stillitano, Cllr Vincent, CCllr Bevan, DCllr Penfold, and two members of the public.

- 1. APOLOGIES FOR ABSENCE The Clerk, Alan Bennett
- 2. DECLARATIONS OF INTEREST None declared
- 3. TO APPROVE AND SIGN THE MINUTES
- 3.1 It was resolved "THAT THE MINUTES OF THE MEETING HELD 19<sup>TH</sup> MAY 2015 BE APPROVED AND SIGNED BY CHAIRMAN". Unanimously agreed
- 4. FINANCIAL MATTERS
- 4.1 Clerk's salary for 2 months. Total: £305.94 Proposed: Cllr Bugler, 2<sup>nd</sup>: Cllr Smith. Unanimously agreed.
- 4.2 Clerks invoice for 2 months broadband at £5 per month, £10. Proposed: Cllr Bugler, 2<sup>nd</sup>: Cllr Smith. Unanimously agreed.
- 4.3 Check that signatory mandate forms with Cllr Scutt and Cllr Bugler have been completed and submit. Cllr Scutt confirmed this had been done and clarified with Lloyds Bank.
- 4.4 Complaint made to Lloyds bank regarding acquiring forms. Letter received indicating that due to the inconvenience they will credit Leigh PC account with £1500.00, however payment to bank account is only £150.00. On further enquiry it was a typing error. However due to the inconvenience a letter has now been received indicating that a further £150 and extra £25, giving a total of £325 will be credited to the Leigh Parish Council.
- 4.5 Cheque received of £375.00 from Dorset County Council for 3 gates within Leigh PC how does the Council wish to proceed? It was unanimously agreed Leigh PC would match this figure to allow for a total of 6 gates to be replaced. Councillors discussed different aspects including type of gate and of the best way to proceed regarding land owner consent and ongoing maintenance. Cllr Scutt and Cllr Vincent to progress. CCllr Bevan advised additional monies may be available in the next financial year for the replacement of additional gates.
- 4.6 Clerk contacted insurance company after the last meeting and managed to get a reduction to £649.25 which has been paid. On what basis does the Council wish to review their insurance for the next year? It was unanimously agreed that the clerk should speak with known neighboring Parish councils who use the same insurance company to see if we could get a group reduction. The term and scope of cover for the policy should be agreed by Leigh PC prior to renewing next year
- 4.7 DAPTC Annual subscription due £148.95 due. Unanimously agreed Proposed: Cllr Bugler, 2<sup>nd</sup>: Cllr Vincent.

6.1 Cllr Bugler advised there is still no appointed 'Chairperson' of the Play Park Committee. The Play Park Committee continues to work with the village hall committee in identifying a new location. It is understood that article will be published in the Wriggle Valley Magazine by the Play Park Committee asking for volunteers for the position of 'Chairperson 'for the Play Park Committee.

Following an change in the complaints process in which now individual residents must raise objections to the BC directly detailing how changes affect individuals it was unanimously agreed, as this was unrealistic, to reluctantly accept the decision but to request MP Oliver Letwin deposits the objection with parliament for the record.

It was agreed the first step in the process of creating a Leigh Community Emergency Response Plan was to identify the 4 or 5 most appropriate to Leigh emergency risks the plan should address.
